## **INSTRUCTIONS:**

- 1. Owners who own more than one lot may list all their lots on one form unless:
  - a. Their lots do not all have the same legal owners.
  - b. The designated contact will not be the same for all lots owned.
- 2. Legal owners who want to designate a contact must sign and include their information on the form.
- 3. Only one designated contact will be accepted per lot.
- 4. An original notarized copy must be provided to the HOA. Please be aware that your designated contact will be effective as of the date the HOA receives the original notarized copy of the form.

Dear Owner(s),

A designated contact is someone whom you are giving the HOA authorization to correspond with and receive copies of everything that you, as the owner, receives from the HOA. If you appoint a designated contact for a lot you own within Spyglass Ridge HOA, Inc. you are still responsible for the payment of annual assessments, fines, fees, special assessments, etc.

Designated contacts remain in effect until the HOA receives, in writing, instruction to remove the designated contact. Both the paperwork to appoint a designated contact and a request to remove a designated contact must be in writing with signatures notarized for the HOA to honor the instruction. All legal lot owners who are choosing to have a designated contact must have a notarized signature.
