## **OTHER MISCELLANEOUS INFORMATION:**

-Wi-Fi access at the RCC has changed and the new information has been posted in the kitchen on the outside of the upper cabinet door closest to the fire extinguisher and on the inside of the left door under the television in the main room.

-The propane tank for the BBQ at the swimming pool has been refilled and is available for community member use. We also have a new set of BBQ utensils that will be kept in the kitchen at the RCC. If you use them please wash them and return them to the kitchen when you are done.

-The RCC parking lot has been restriped, thanks to the board President Don Carlson, so there should be no further question as to where each parking space is located. Please remember when parking at the RCC there are a limited number of spaces and it is very tight to get in and out of the lot itself. Do not take up more than one space when parking and if you are in a larger vehicle please consider parking along Lookout Lane.

-I have received a lot of reports of dogs being off leash and not under control by their owners on our SGR walking trails and throughout the community. Please remember that the HOA no longer gets involved with citing community members for a violation when this occurs but instead advises anyone with a complaint to contact Mesa County Animal Control to report the incident. With that said SGR owners are still required to have their animals under their control at all times while on HOA property even if they are not required to be on a physical leash.

-Since the start of the summer I have received complaints about children riding up and down Spyglass Drive on a variety of things such as the one-wheel things, scooters, bikes, etc... in a very unsafe manner and drivers are concerned. I have had reports of riders darting out from Eagle Ridge Drive and riding in the street down (and up) Spyglass Drive. So, I wanted to ask parents to please have a discussion about riding safety with your children. There are a lot of areas throughout the community that drivers may not be able to react quickly enough to someone darting in front of their
